

Frequently Asked GTE Interview Questions

- 1) Tell me about your academic background
- 2) After finishing school, what have you done? (Check for gaps, different story to the one on the application)
- 3) If you are changing into a new field etc, why are you changing? (We are looking for commitment and motivation).
- 4) Why do you want to study in Australia and not in Nepal/ India, USA or UK?
- 5) Which course have you applied for and why aren't you studying a similar course in Nepal/ India)
- 6) Why did you choose this college/universities? What other universities/colleges you have researched in Australia for similar course? (Compare at-least 3 to 4 providers)
- 8) How much is the tuition fees per year and living cost in Australia? How much total investment you will have to do to complete your studies? (AUD 20290).
- 9) What is the duration of the course and how long you are going to stay in Australia?
- 10) How many subjects must you study each semester/year?
 - Core subjects
 - Electives subjects
 - Specialization subjects
- 11) How many subjects is there altogether in your course?

Future Career

- 12) What is your career plans after you have finished your studies in Australia?

14) How will you benefit from studying this? (We are looking for a good knowledge of their future career path, the benefits from studying and the opportunities they will have after graduation).

15) What salary will you earn and how long it will take you to return your investment?

16) What are the Visa conditions that you must obey while you are studying in Australia?

(We are looking for knowledge about only being able to work 20 hours a week throughout the semester, need to attend regularly and to progress each semester, being unable to transfer to another Education provider until they have completed 6 months of their principal, need to maintain OSHC during study, need to update DHA & provider if you are changing your resident address

17) If Parents are going to pay, what do your parents do? How much is their income and how many family members are dependent on this income?

18) Do you have Education Loan or Saving to pay your fees and how much funds are available for you.

19) Are you aware of all your expenses?

Tuition Fee, Living Cost, Travel Expenses, OSHC

20) Do you plan to work when you are in Australia and what kind of jobs will you do during your studies? Do you know working hour right for int'l students in Australia?

21) Where will you live in Australia and how fare is it from your campus?

22) Are you married or do you plan to be married soon?

If you are married, when were you married?

Do you have any children?

If so, what are their ages?

21) Do you have relative/friends in Australia and what they do?

22) Do you know refund policy, if your visa is refused, how much fees is non-refundable or after visa approval, if you do not join our college/university, your paid fees will not be refunded

23) Have you or your family members travelled to any countries before? For what purpose, how long did you stay there

24) Has your student visa application been rejected before by the Australian High Commission or any other countries? If so why and when?

25) What do you know about GTE ?

26) What is PSW, can you explain in details?
